




Updates on Bharuch-Dahej Road

Road Connectivity make a crucial contribution to economic development and growth and bring important social benefits. They are of vital importance to growth and development. In addition, providing access to employment, social, health and other services makes a road network crucial for development of any industrial estate. In case of Dahej PCPIR, we are connected with nearby city Bharuch via State Highway No.06, a main source of people & goods vehicular movement. In the interest of people & industries it is essential to maintain the road in well & up to date condition, we have done efforts to get optimum results like.....

Dahej Industries Association has done continuous representation for redeveloping the state highway number no. 6 for smooth connectivity between Dahej to Bharuch from Zone office of GSRDC to State & Central Ministry offices of Road & Transportation Department continuously since March 2018. As a result of the same we got approval for Access Controlled Expressway of INR 800 Crores & also got sanction of INR 160 Crore in F.Y. 2023-24 Budget of GoG.

By looking to the volume of the project it will take to three years for completion. To keeping road in good condition till such time, we have represented concerns to authorities and got approval for 1.5 Crore's budget for Patch Work. Additionally, tender for resurfacing of entire road of Cost INR 48 Crore is inline.







Updates on Project Mini Emergency Response Center

The ratio of emergency accidents is continuous increasing within the Dahej region due to existence of highly sensitive manufacturing divisions like Petroleum, Petro-chemicals, Pharmaceutical, Agrochemical, Chemical, Pigment and other chemical manufacturing Industries.

By looking need of the estate, Dahej Industries Association took a lead to Construct a well-equipped Emergency Response Center in the Estate which will be adequate to meet any emergency of the estate with its own resources. Project will have following Facilities and Equipment
