



### Meetings with Government Agencies

#### Joint Meeting of DGVCL, GETCO & DIA

A joint meeting of the Dakshin Gujarat Vij Company Limited (DGVCL), Gujarat Energy Transmission Corporation Limited (GETCO), and representatives of DIA member industries was held on July 23, 2024, at the Association's conference hall in Dahej. The purpose of this meeting was to address the power supply-related issues faced by industries located at the Dahej Industrial Estate.

During the meeting, participants identified problems related to electricity supply services,

analyzed their causes, and discussed potential solutions. Additionally, they explored ways to enhance the agencies' capacity and manpower to deliver better services.

A total of 39 representatives from industries, GETCO, and DGVCL attended the meeting. Industries raised their concerns individually, while the respective agencies shared the reasons behind these issues and provided appropriate solutions.







### Meeting for the Traffic Management and security of companies & industrial units of Dahej Estate

On September 4, 2024, a joint meeting was convened at the Dahej Industries Association's conference hall to address the growing traffic congestion and security concerns within the Dahej Industrial Area. The meeting was chaired by the Traffic Police Inspector of Bharuch and the Police Inspector of Dahej.

The primary focus of the meeting was to discuss the significant traffic jams occurring on the roads of Bharuch City, particularly on State Highway 06, due to the influx of buses and Light Motor Vehicles (LMVs). Attendees sought to explore potential solutions to mitigate these traffic

congestion issues. Additionally, the meeting aimed to address the security concerns prevalent within the Dahej Industrial Area. Police Inspector Sri Pradip Vaghela of Dahej was also in attendance.

The meeting provided a valuable opportunity for open dialogue between the police department and industry representatives. Through constructive discussions, several potential solutions were identified to address the traffic congestion and security concerns prevalent in the Dahej Industrial Area.









#### **An Environment Clinic**

On June 13, 2024, the Dahej Industries Association (DIA) and the Gujarat Pollution Control Board (GPCB), Bharuch, jointly organized an Environment Clinic at the DIA Conference Hall. The primary objective of this clinic was to educate and guide industries in the Dahej region on environmental compliance, with a particular focus on the XGN Portal and pre-monsoon activities.

The XGN Portal, a GPCB initiative for online submission of environmental returns and data management, was a key topic of discussion. GPCB officials provided in-depth guidance on navigating the portal, understanding its functionalities, and ensuring timely and accurate data submission. This interactive session addressed industry queries and fostered a collaborative approach to environmental regulations.

Furthermore, the clinic emphasized the importance of pre-monsoon preparedness for

industrial units. GPCB experts highlighted essential measures to be taken before the monsoon season, such as maintaining effluent treatment plants (ETPs), implementing stormwater management plans, and ensuring proper storage of hazardous materials. By adhering to these guidelines, industries can minimize their environmental impact during the monsoon and prevent potential pollution incidents.

The Environment Clinic served as a valuable platform for fostering dialogue between industry and the GPCB. The focus on the XGN Portal empowers industries with efficient tools for environmental data management. Additionally, the emphasis on pre-monsoon preparedness ensures proactive environmental protection during the monsoon season. This collaborative approach between industry and regulatory bodies is crucial for achieving sustainable industrial growth in the Dahej region.













### Workshops, Seminars & Sessions

#### Learning Session on Onboarding & Data Entry on ChemIndia Portal

The Dahej Industries Association organized a comprehensive learning session on onboarding and data entry on the ChemIndia Portal. Held at the Association's Conference Hall, this session was conducted in collaboration with and under the guidance of the Department of Chemicals and Petrochemicals (DCPC), Ministry of Chemicals and Fertilizers, Government of India.

The ChemIndia Portal, a web-based platform launched by the DCPC, aims to gather comprehensive statistics on various aspects of the chemical sector, including production, installed capacity, exports, imports, and more.

This data is essential for creating a comprehensive Chemical Inventory of India.

Mr. Ram Sajeevan, Director of DCPC, and Mr. Mohit Kumar Sinha, Data Analyst, were present to provide in-depth insights into the portal's purpose and usage. The session commenced with a warm welcome to the dignitaries, followed by a detailed presentation with a live demonstration by Mr. Mohit Kumar Sinha. A question-and-answer session provided an opportunity for participants to seek clarifications. The event concluded with a vote of thanks.







#### Session on causes of Alerts on VLTS Software & Precautionary actions to avoid it

On July 20, 2024, the Dahej Industries Association hosted a workshop to address the growing concern of frequent and often unnecessary alerts generated by the Vehicle Location Tracking System (VLTS) used for hazardous waste transportation. Over 25 industry representatives attended the session.

The Gujarat Pollution Control Board (GPCB) implemented the GPS-based VLTS system to ensure safer transportation of hazardous waste. However, many member industries reported receiving numerous alerts, such as route

deviations and power disconnection notifications, which were often caused by driver errors or issues with transporter agencies. These alerts led to unnecessary communication and documentation requirements.

During the workshop, participants discussed various reasons for these alerts and explored preventive measures. The meeting concluded with a decision to advocate for solutions to the GPCB on behalf of both the association and its member industries.









#### **NABL Accreditation Awareness Session for Dahej Industries Association**

Dahej Industries Association (DIA) and the National Accreditation Board for Testing and Calibration Laboratories (NABL) jointly organized an awareness session on NABL accreditation on August 2, 2024, at the DIA Conference Hall. The purpose was to educate and sensitize industries and laboratories in the Dahej region about NABL accreditation.

The session began with a warm welcome to all participants, followed by inaugural remarks. Dr. Bhumi Rajyaguru, Deputy Director of NABL-

Quality Council of India (QCI) Ahmedabad Regional Office, conducted the entire session. Topics covered included an overview of NABL and accreditation, the accreditation process, filing applications on the NABL portal, the NABL website, the Recognition Scheme for Temporary Site Laboratories Testing Aggregates and Concrete in Building Projects, and the Medical Entry Level Testing Labs Program. The session concluded with a question-and-answer session and a vote of thanks.







### Technology Seminar on Cutting Edge Digitalization Technologies in field Instrumentation & Gas Analytics

Dahej Industries Association (DIA), in partnership with Bharuch District Management Association and Siemens Limited, successfully conducted a technology seminar focused on "Cutting-Edge Digitalization Technologies in Field Instrumentation & Gas Analytics." The seminar took place on May 17, 2024, at Hotel Fortune Park, Dahej.

The event delved into a range of advanced topics, including:

- Cutting-edge IIoT and AI-based field sensor technology
- Futuristic digitalization architecture concepts utilizing IIoT, cloud technology, and AI-based field sensors

- Smart gas analytics technologies and Alenabled digital applications
- Real-world industry case studies with a factory tour showcasing the deployment of Al-enabled field sensor technology on critical process equipment

#### Review Meeting on State Level Chemical Industries Mock Drill by DISH

The National Disaster Management Authority, New Delhi, had planned a state-level chemical industry mock drill on August 1, 2024, at 9:00 AM. This drill involved exercises at 59 industries, port terminals, and pipeline terminals across Gujarat. Among these, Dahej had five participants:

A review meeting was conducted under the chairmanship of Shri P M Shah, Director of Industrial Safety & Health, Gujarat, at the

conference hall of Dahej Industries Association on July 26, 2024. Attendees included Shri R A Patel, Joint Director of Industrial Safety & Health, Shri D K Vasava, Deputy Director of Industrial Safety & Health-Bharuch, the DISH-Bharuch team, office bearers of Dahej, Saykha, Vilayat, and Ankleshwar Industries Associations, and representatives of 13 participating industries.

Beyond discussing the planned mock drill, Shri P M Shah provided valuable insights to the industries on the importance and requirements of: 1) Stability Certificates 2) Confined Space Entry 3) Guarding/Fencing of Machinery 4) Updated On-site Emergency Plans 5) Safety Audits 6) Emergency Exits 7) Flame-Proof Fittings 8) Compliance with Circulars.









#### Session on Fire NOC awareness

In light of the recent fire incident in Gujarat state, there has been a significant rise in the demand for Fire NOCs from various authorities and agencies. Media coverage and insurance companies have also emphasized the importance of this certificate, leading to some confusion among industrial members.

To address these concerns and provide clarity on the requirements for Fire NOCs for industrial units, the Dahej Industries Association, in partnership with the Dahej Eco-Friendly Society (Disaster Management Center-Dahej), organized a session to enhance understanding of the Fire NOC. The speaker for the session was Mr. L. K. Dungrani, a retired Deputy Director of Industrial Safety and Health.

Mr. Dungrani provided valuable insights into the Fire Safety Certificate (NOC), covering various aspects such as circulars, amendments to laws, terminology of rules and regulations, and how industries can comply with these requirements.

Chaired by Shri M. G. Surti, Chief Engineer (Operations & Maintenance) at the Corporate Office, DGVCL, the meeting focused on the following key points:

- Identification of root causes of recurring issues.
- Manpower requirements for efficient and improved services.
- Infrastructure-related needs.
- Progress on underground cabling work.
- Coordination between DGVCL and GETCO.

During the meeting, both individual and feeder-wise issues of the industries were discussed, and the agencies provided proposed or ongoing solutions to address them.









#### Representation - Electricity related Issues at DGVCL-Dahej & Corporate office Surat

On July 19, 2024, the Dahej Industries Association and Laghu Udyog Bharti-Dahej, representing over 125 industries, submitted petitions to the DGVCL's Dahej subdivision office to address pressing electricity supply issues.

The majority of Dahej region's industries rely on Dakshin Gujarat Vij Company Limited and Gujarat Energy Transmission Corporation for their power supply. In recent months, these industries have experienced frequent interruptions, including jumper breaking, power surges and dips, tripping, outages, and blackouts.

The representatives presented concerns about substation renovations, coordination between DGVCL and GETCO, insufficient manpower in divisional offices, service connection problems in GIDC, and the need for a separate divisional office for industrial connections.

Apart from these Office bearers of Dahej Industries Association had a meeting with Managing Director of Dakshin Gujarat Vij Company Limited to discuss all these concerns













### Meeting with Finance & Energy Minister, GoG

The Dahej Industries Association recently convened a meeting with Shri Kanu Bhai Desai, the Minister of Finance and Energy for the Government of Gujarat. The primary objective of this meeting was to address various concerns and issues faced by the industrial estates in Dahej.

Key topics discussed during the meeting included:

- Electricity-related issues: The association highlighted the need for reliable and uninterrupted power supply for the smooth functioning of industrial units. Specific concerns raised included fluctuations in voltage, frequent power cuts, and delays in resolving technical issues.
- Promotion of MSME units through export promotion: The association sought support from the government in promoting and facilitating exports from Micro, Small, and Medium Enterprises (MSMEs) located in Dahej. This included requests for assistance in obtaining export licenses, market research, and participation in international trade fairs.
- Infrastructure-related requirements: The association emphasized the importance of adequate infrastructure for the growth and development of the industrial estates. This included demands for improved road

- connectivity, better water supply facilities, and efficient waste management systems.
- for Dahej-Bharuch Expressway: A significant point of discussion was the proposed use of bitumen for the Dahej-Bharuch Access Controlled Expressway. The association strongly advocated for the reconsideration of this decision and requested that Reinforced Cement Concrete (RCC) be used instead. RCC is considered to be more durable, require less maintenance, and provide a smoother driving experience.

In addition to meeting with the Minister of Finance and Energy, the association also had the opportunity to interact with the Hon'ble Chief Minister of Gujarat State. The association expressed its gratitude for the government's support and initiatives aimed at promoting industrial growth in the state.

The meeting concluded on a positive note with the assurance from the government officials that the concerns raised by the association would be addressed in a timely and effective manner. The Dahej Industries Association remains committed to working closely with the government to create a conducive environment for industrial development in the region.




